
HOME OF MISTY RIVERS PLANTATION

Non-Regular Classes (Involving Single Dog Entries)

Veteran Dogs, 7 Years & under 10 Years

Veteran Bitches, 7 Years & under 10 Years

Veteran Dogs, 10 Years & Older Veteran Bitches, 10 Years & Older

Spayed and neutered animals may be entered and shown in Veteran Classes at specialty shows.

Dual Champion Dogs Dual Champion Bitches

Any dog that has been awarded the title of Champion of Record may be designated as a "Dual Champion" after it has also been awarded the title of Field Champion. Entrants must be intact. Spayed and neutered animals are not eligible. Winners of the above non-regular classes may also compete for Best of Breed, provided they are undefeated in any other class at this show.

Best of Breed Competition (no defeated dogs will be allowed to compete)

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC (Ch. 3, Sec. 13 AKC Rules Applying to Dog Shows).

SELECT DOG SELECT BITCH

AWARD OF MERIT: The maximum number of Award of Merit prizes will be one per ten Basenjis competing in the Best of Breed Competition, with a maximum of 6 prizes awarded at the Regional Specialty and a maximum of 10 prizes awarded at the National Specialty. BOB, BOS, SD, SB, WD, and WB are not eligible for Awards of Merit, but do count when calculating the number of Awards of Merit available.

BEST PUPPY IN SHOW: Will be awarded by the conformation judge immediately following the Award of Merit presentation. The winner of each of the four puppy classes (6-9 & 9-12, BBE puppy, each sex) will compete for this Award. Puppies MUST be entered in one of those puppy classes to be eligible for this award. Should a puppy class winner go Best of Breed or Best of Winners it would be automatically awarded Best Puppy in Show. If a winner of a puppy class should go Winners Dog or Winners Bitch, only that puppy of its sex would compete against the puppies of the other sex.

BEST BRED BY EXHIBITOR IN SHOW: Award will also be given by the conformation Judge immediately following the awarding of Best Puppy in Show. The winner of each of the four BBE classes will compete. Dogs must be entered in the BBE class to be eligible to compete. Should a BBE class winner go Best of Breed or Best of Winners, it would automatically be awarded Best BBE in Show.

BEST VETERAN IN SHOW: Award will also be given by the conformation Judge immediately following the awarding of Best Bred-By Exhibitor in Show. The winner of each of the six Veteran classes will compete for this Award. Dogs must be entered in one of the Veteran classes to be eligible for Best Veteran in Show.

Non-Regular Classes (Involving Multiple Dog Entries)

NOTE: As the judge's decision in the Stud Dog, Brood Bitch, Brace Class is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

STUD DOG CLASS BROOD BITCH CLASS

Each entry is allowed two get/produce. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get/produce must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get/produce must be entered in another class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get/produce being exhibited, must wear armbands.

BRACE CLASS TEAM CLASS

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class." Beginning July 2, 2025 dogs & bitches entered in this class, may be spayed or neutered.

Team Class: Four Dogs, with the same requirements as Brace Class, but as a Team of Four Dogs. Beginning July 2, 2025 dogs & bitches entered in this class, may be spayed or neutered.

GENERAL INFORMATION AND SHOW RULES

ENTRY FEE: for the first class in which a dog is entered is \$30.00, except Puppy classes, Bred By Exhibitor classes, Veteran classes, and Stud Dog/Brood Bitch/Brace/Team classes, for which entry fee will be \$25.00 (includes the AKC Recording & Event Fees). Each additional class for the same dog is \$25.00. **Junior Showmanship is FREE.** All Sweepstakes Puppy & Veteran (need not be entered in a Regular Class) entry fees are \$25.00.

NOTICE TO EXHIBITORS: A Recording Fee of \$.50 cents and a \$3.00 Event registration fee will be required for each dog entered at any licensed or Member Club Show, Obedience Trial, or Tracking Test. This Recording Fee is to be collected by the Show giving Club and paid to the AKC. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2.)

IF THE SAME DOG is entered in more than one class the highest priced class shall be considered the first entry.

CLOSING DATE for entries is 8:00 p.m., Wednesday July 2, 2025, after which time entries cannot be accepted, cancelled, or changed, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

WVBC INSUFFICIENT FUNDS POLICY - Any checks to the WVBC and/or Show Secretary returned for Insufficient Funds, must be paid in cash or money order for the NSF amount plus bank fees. If the debt is not paid in full within 60 days of bank processing, the check writer will be unable to enter any WVBC events until the debt is cleared. Entries will NOT be accepted from any exhibitor that owes any amount of monies to the Club.

NOTICE TO EXHIBITORS

ONLY DOGS THAT ARE ELIGIBLE to be shown under The American Kennel Club rules shall be allowed within the show precincts.

HEALTH REQUIREMENTS "Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NO ENTRY shall be accepted which specifies any condition as to its acceptance.

TO BE ACCEPTABLE an entry must be submitted with required entry fee on an official American Kennel Club entry form. **OWNERS ARE RESPONSIBLE** for errors in entry forms regardless of who may make such errors.

LATE, INCOMPLETE ENTRIES, UNSIGNED, UNPAID, OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED AND WILL BE RETURNED TO SENDER.

NO DOG WRONGLY ENTERED in a class may be transferred to another class.

CHANGES OR ADDITIONAL INFORMATION cannot be made by telephone. Such information must be received in writing or telegram prior to the closing of entries as published in the Premium List.

IT IS THE RESPONSIBILITY of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of the dogs or the handlers of the dogs alone are responsible for the presence of their dog in the judging rings. This means it is not the responsibility of the ring steward nor of any agent of the show-giving club to locate any dog, its owner or handler when the dog's presence is needed in the judging ring.

THERE SHALL BE NO DRILLING or intensive training of dogs on the show grounds. ALL DOGS shall be kept on leash.

THE SHOW SECRETARY, THE SHOW CHAIRMAN AND WVBC assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further, assume no responsibility for injury to children. The welfare of an exhibitor or spectator's child is assumed to be the responsibility of the exhibitor or spectator. It is distinctly understood that exhibitors and spectators will exercise control and restraint over their children on the day of the Show.

ENTRY FEES shall not be refunded in the event that the dog is absent, disqualified, sick, lame, "in season", excused by the veterinarian or judge, or barred from competition by action of the Show Committee. If, because of riots, civil disobedience, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs

will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled by an owner/handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the point show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition. If the replacement handler is an eligible owner/ handler for that dog a change can occur. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

AWARD OF MERITS

After the regular Best of Breed judging, the judge may at his/her discretion award up to a maximum of six (6) Awards of Merit, to any competitor for Best of Breed other than the Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch, Winners Dog and Winners Bitch winners. The judge is not obligated to award any Awards of Merit, if he/she feels there are not any dogs or bitches in competition worthy of this award. The total number of Awards of Merit the judge is allowed to award is dictated by the total number of Dogs and Bitches, the COUNT to include the WD and the WB, competing in the Best of Breed Competition as follows:

Junior Showmanship Competition

Novice Class - For Boys and Girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have not won 3 first place awards, with competition present, in a Novice Class at a licensed or member show.

Open Class - For Boys and Girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have won at least 3 first places in a Novice Class at a licensed or member show, with competition present.

Master Class - This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
